

Official Rules and Regulations for “Enter to Win Miromar Outlets Gift Card” Contest.

The Miromar Outlets “Enter to Win Gift Card” Contest (“Contest”) begins at 10 a.m. Eastern Time (“ET”) on January 1, 2025, and ends at 9:00 p.m. ET on December 31, 2025. The contest is open to individuals aged 18 and older who are legal residents of the United States and Canada only. Employees, family members, and/or affiliates or subsidiaries of Miromar Development Corporation and Miromar Outlets, its tenants, their employees, and family members are NOT eligible to participate.

HOW TO ENTER: Fill out the entry form included in the advertisement or an Enter to Win paper or digital form and submit it to the Mall Office or a promotional Enter to Win Box located at within Miromar Outlets at 10801 Corkscrew Road, Estero, Florida 33928.

LIMIT: One entry per person/household during the entire Contest entry period.

Gift Card (“Prize”).
