

## **Official Rules and Regulations for “Enter to Win Miromar Outlets Gift Card” Contest.**

The contest is open to individuals aged 18 and older who are legal residents of the United States and Canada only. **HOW TO ENTER:** Fill out the entry form included in the advertisement or an Enter to Win paper or digital form and submit it to the Mall Office or a promotional Enter to Win Box located at within Miromar Outlets at 10801 Corkscrew Road, Estero, Florida 33928.

**LIMIT:** One entry per person/household during the entire Contest entry period.

Gift Card (“Prize”).
